

TERMS AND CONDITIONS FOR “EFC 82 COMPETITION” PROMOTIONAL OFFER

02/09/2019 (hereinafter the “Terms”)

The promoter is GLOBAL CAPITAL MARKETS TRADING SOUTH AFRICA Ltd trading as CM TRADING (Registration No. 2013/045335/07) whose registered office is at 14th Floor, Sandton City Office Tower 9, Corner Rivonia Road and 5th Street, Sandton, Johannesburg 2196, South Africa.

1. The EFC 82 COMPETITION 2019 is open to residents of the Republic of South Africa (RSA) and Lesotho, aged 18 (eighteen) years or over, except employees of the promoter and/or their close relatives and/or anyone otherwise connected with the organization or judging of the competition.
2. The EFC 82 COMPETITION 2019 is offered solely to fully verified, compliant and funded Trading Accounts.
3. The “entrant” is the person whose name is identified on the trading account.
4. Customers are prohibited from opening multiple accounts with the Company for the sole purpose of creating multiple entries.
5. One client holding both a private and a corporate account with CM Trading is considered to be one customer and is therefore eligible for one entry in the competition.
6. By entering the EFC 82 COMPETITION, an entrant is indicating his/her agreement to be bound by these Terms and Conditions.
7. Starting date for the EFC 82 COMPETITION is September 3rd 2019. No entries will be permitted before this date.

10. Each deposit of 250 currency units made within the abovementioned dates on an eligible account will grant the Customer 1 (one) point.

For example, if the total amount of deposits from the referred clients equals 54,551 USD, the amount of points for this Customer will be 218 (54551/250 = 218.20)

13. Every withdrawal of at least 250 currency units from the trading account will remove 1 (point) from the total.
